The Cooma Chamber of Commerce (Suzanne is a member) launched a campaign to encourage residents to spend more money in the local area, the Cooma Gift Card being the result.

The card can be loaded at ten different businesses in Cooma and can be used in purchases at 56 different businesses. The card does not cost anything, thanks to the sponsorship of Snowy Hydro and the Cooma Ex-Services Club. This scheme is being used in several country towns, Narrabri being the pioneer town and owning the intellectual property of the scheme. Cooma is the first town in the scheme to reach \$100,000 within the first 12 months of operation.
